As a member of a Restaurant/Beverage Association you are entitled to discounts on ASCAP's Restaurant-Tavern-Nightclub and Similar Establishment License Fee:

- Association members who pay their annual music license fees to ASCAP by January 20th of each year are entitled to a **20% discount!** (Member must be in good standing with Association and ASCAP.)

OR

- All Association members who pay within 30 days of a trimester billing will receive a **10% discount** on license fees. (Member must be in good standing with Association and ASCAP.)
- For a limited time, ASCAP will waive all finance charges for the Association members with outstanding account balances who send in their overdue license fees. Contact ASCAP or your Association for more information on the deadline.
